V. **DISCUSSION AND/OR ACTION:** Approval of minutes for the Regular meeting held on Thursday, March 26, 2015.

DISCUSSION: Chairman Barrett states that Mr. Easter is not in attendance. He further states "Mr. McMillan approved the sign accept that he noted that the ice cream cones were not period correct to the historic period." So maybe not to 1880's I don't know how they differ from up into the later part of the historic district. Also it seems to me to be pretty restrictive that; that is a specific type of ice cream cone that he is selling. Why can't he show his wears in the window? I mean if you are selling a non historic item, shot glass that says Tombstone on it or something, you need to get it in the window. That would be my comment.

Commissioner Troncale: Is this the actual sign?

Chairman Barrett; "it's a sample. It is going to be made of metal."

Commissioner Pakinkis; "Mr. Chairman during the Territorial period the first cones to come out that were utilized were sugar cones not regular cones. Those are wafer cones I would think."

Chairman Barrett; "The historic district goes up to what time period?" It goes up to what date?"

Chairman Barrett; "I think the twenty ninth.

Commissioner Troncale: "Nineteen twenties according to ... into the twenties."

Chairman Barrett; "are there any experts here that know if we had wafer cones at that time."

No one answered.

Chairman Barrett; "that was Mr. McMillan's comment. The comment was simply whether this was historic or not. It is the item he is selling. Should he be able to show a picture of that item?"

Commissioner Pakinkis; "because the original cone that they were using was displayed at the Chicago World's Fair in the eighteen nineties. It was because it was their ice cream and they didn't have any sort of ... the guy next door made the waffle cone.

Commissioner Troncale; "It was eighteen ninety two." We can agree that it was a cone whether it was a waffle or sugar (inaudible) see much difference."

Chairman Barrett calls for a motion for approval and you can state whether you want it approved with or without the ice cream cones themselves.

MOTION by Commissioner Troncale, **SECOND** by Commissioner Pakinkis to approve as is.
