City Attorney Bays - "Yes Mr. Mayor; before we started today's council meeting I had a brief discussion with you. I am going to ask that the court, sorry, that the Council not take this action up at all based primarily on a letter that we received from the Tombstone Unified School District dated; December 29, 2015 objecting to Council providing a variance clearly based on the fact that the Tombstone Unified School District still owns that property and the location of where this dispensary is suppose to be is in essence across the street from the school grounds. It appears that it would be in violation of a significant State statue and the Council; the City would be opening themselves up to litigation with the State to go forward. So I am respectfully recommending to you Mr. Mayor that you not even put this on the agenda today. Not even a table. Just take it off for purposes of discussion."

Chairman Escapule; "Having said that Mr. Bays, This item will be taken off the agenda. This Board of Adjustments and Appeals Hearing will therefore be closed. No action taken! This however doesn't mean that the applicants can't reapply for a different location. This has nothing to do with their application for the particular

So what we are going to do is try to obtain enough finances to purchase patrol cars, equipment for Public Works Department and also some additional fire equipment. Ruben Villa the Financial consultant has determined that one months cost of repairing all of this equipment could make six months payments toward this and we could do it under a bond; financial bond type thing, with a low interest at one and a half or two percent interest. In which only makes sense because we are just continually going backwards.

So what is happening is Pioneer Title is actually becoming more strict with their title research and they are finding these (Inaudible) on these titles and in order for these people to have a clear title on their property the City has to give these. Am I correct in all of this Mr. Bays? I should have let you do this.

City Attorney Bays; "No you are doing fine.

Mayor Escapule; "Okay, so we actually need to give them a Mayor's Deed or in this case it would actually be a Warranty Deed from the City of Tombstone and I am not sure who their deed is going to but I am sure that Pioneer Title Company is handling it. So that is what that is all about. This is the second one we have done in the last sixty days.
