So there really is not much other than if things should be discussed in an open meeting so if you have questions normally the best time to bring them up is in open meeting for discussion. Don't be calling each other and saying what do you think of this or what do you think of that!

Secretary Duran; "That also applies to emails because email are monitored also!"

Chairman Schmidt; "Okay! Well I am not giving anybody my email!"
