VI. PUBLIC HEARING ON THE FINAL BUDGET AND PROPERTY TAX LEVIES

Ruben Villa, Finance Director -

Good evening Mayor and Council. This is the opportunity for the public to address the Mayor and Council after the City has published the tentative budget for two consecutive weeks. Tonight after the closing of the hearing the City Council will have the opportunity to adopt the final budget and the property tax levies.

The budget total is exactly the same as the tentative budget. This year the property taxes will be taxed lower than in prior year by about twenty cents per a hundred dollars of valuation. The result of lower valuations throughout the City and lower bond payments contributes to lower tax rate. The combined tax rate will be \$1.77 per hundred dollars of valuation. The only difference the taxes are for residential calculated on ten percent of the valuation and eighteen per cent for commercial properties. It is not based on the full value that is represented in the tax code.

Mayor Escapule asked if anyone from the general public would like to address the City Council/Finance Director Villa with questions regarding the budget. No one from the public responded.

Councilmember Bachman; "but they are requesting the motorcycles park on 5th.

Mayor Escapule; "Right."

Councilmember Bachman; and the display only in front of (inaudible) on Allen.

Councilmember Villa; "We are chasing groups. We have refused a lot of people on Allen Street.

Mayor Escapule; "We have to make sure what this motion is that I just read is....

Councilmember Villa; "Correct with the request."

Councilmember Barlow; "Those motorcycles going to be displayed on Allen Street?

Councilmember Bachman; "It reads that the motorcycles will be displayed on 5th Street. What they are asking is to place a trailer.....

Councilmember Villa; "the original request to park display of motorcycles on Allen Street."

Councilmember Barlow; "We are planning night motorcycle rides and would like to be able to park / display motorcycles on Allen Street." "My question is who's motorcycles are going to be parked or displayed on Allen Street?"

Councilmember Villa; "Motorcycle riders, Harley riders, who else would you expect?"

Interim City Clerk lkirt; "Did you want me to read this letter?"

Councilmember Barlow: "We have copies."

Interim City Clerk: "You have the copies."

Mr. Steve Goldstein: Would you like a clarification of what you are talking about?"

Mayor Escapule; "Sure."

Mr. Goldstein: "When we first did the ride to Allen Street we had two hundred and fifty bikes then we had three hundred and fifty bikes and then it was relegated to be a side show between Fremont and Allen and Harley Davidson was very disappointed. It was really not interfering with anybody else's businesses and I still feel that if you want to invite people to do business in Tombstone you should at least honor what their request are if it does not interfere with anybody else. Our place in the cameo of things is Allen Street. Now I can concur with let's say the Dragoon Saloon having wanting to have something by theirs. If they were in charge with what they did with the antique cars they certainly can request to have it in their area. They same thing with the Crystal Palace; if they want to do something and they are running it they should be able to ask for where they want it to be. When it comes to Tombstone Harley Davidson: I and Harley Davidson don't want it to be a side show because lot of the people that saw the bikes come and be relegated between 5th and the highway they came they saw they left. They spent very little money there. Instead of going around to the different businesses which we advised them to do. What I would like to be able to do is to be able to park up on Allen Street if possible not interfering with anyone else's business. They bring a trailer with paraphernalia which they expose to other people that Harley Davidson wants to expose to the public. It's a small trailer not a forty foot trailer it's about sixteen foot. That's all it is and we had to park it on the side street last time and Harley Davidson was very disappointed. You are not going to get a lot of people wanting to do business in Tombstone if you relegate them to be a side show. If it is at all possible we would like to be able to park the bikes which they pristinely polish and clean and are very proud of; it's an American product and put them on Allen Street and let them have their little trailer right there in front of

the Harley Davidson store or where they would like to have it to cameo the product. They bring a lot of people to Tombstone, they pay a lot of taxes, we pay a lot of taxes we do a lot of advertising probably twenty thousand dollars worth in advertising for Tombstone. I wish you would back up the companies that back up Tombstone. They do it in other cities. Once again it would be nice to have it between the Harley Davidson Store and off 5th Street and this would show them that they are not just a side show. " "Thank you."

Councilmember Barlow; "Mayor, once we start parking vehicles and motorcycles (inaudible) on Allen Street you might as well start at the next meeting to rescind the ordinance that we have." We can't do it a little bit (inaudible) there is no such thing..." Mr. Goldstein; "Yes there is because you're allowed to do it on special occasions and on special occasions...."

Mayor Escapule; "Excuse me Mr. Goldstein; I am not going to get into an argument."

Mr. Goldstein; "I am just answering." "I think it would be up to the city attorney and you guys to read your own regulations because it is allowed on special occasions to park on Allen Street. Whether you like it or not."

Councilmember Villa; "If it benefits the City of Tombstone, we can't even afford to pay a luncheon what does that tell us. We can't afford to pay fifteen peoples luncheon and we are hurting for money. These people ..."

Mayor Escapule; "Excuse me. I am going to ask that this item be tabled until I can get a legal opinion from Mr. Bays so we can do a little more research.

MOTION by Councilmember Bachman, **SECOND** by Councilmember Villa to discuss request by the Tombstone Forward Association for a special use permit for the use of Third Street from Allen Street to Toughnut Street on Sunday, September 20, 2015 between the hours of 6:00 a.m. to 3:00 p.m. for a staging area for wagons and select parade participants. A further request for a special use permit for a parade to be held on Sunday, September 20, 2015 on Allen Street.

DISCUSSION: Councilmember Bachman; "Number one we had the request from the Courthouse the approval for the same area and for the parade. I am just wondering why it is on here again through Tombstone Forward?" "Also, with the wagons I thought during the original discuss about this event that the wagons were here for a race not to be set up and I don't know if they are selling anything or what they are doing but they were to be here for the wagon races."

Councilmember Moreno; "there are no wagon races. (inaudible). There was no request for a parade on the application. Actually it was for the use of the street from Allen to Toughnut in coordination with what they are doing at the Courthouse

for after the parade so that people can take pictures with the wagons and some of the people that were in the parade."

Councilmember Bachman; "Okay, and the ball field. What's happening at the ball field?"

Councilmember Moreno; "there is nothing on the ball field."

Councilmember Bachman; "Okay."

Councilmember Villa; "so you are not staging any wagons or any vendors on the football field?" You are not getting money to clean the field for that reason?"

Councilmember Moreno; "Excuse me?"

Councilmember Villa; "your not cleaning the field for wagons or anything?"

Councilmember Moreno; "There is going to be a chuck wagon competition but that's not part of this request.

Councilmember Villa; 'Exactly"

Councilmember Moreno; "That request has already been granted and"

Mayor Escapule; "Hold on, the football field has nothing to do with the City of Tombstone. Nothing to do with us. This is the item that we are discussing right now and that is the only thing we are going to discuss." It's the only thing that is on the agenda."

Councilmember Moreno; "I would like to amend the request to read just the use of Third Street from Allen to Toughnut and to take out the request for the parade since (inaudible).

City Attorney Bays; "Just strike out the last sentence and I think we would be good to go we don't have to amend it."

Councilmember Bachman; "the only reason I brought this up is because initially under the first approval of this the wagons were going to be staged at the football field now they are being staged here. That's the only reason..."

Councilmember Moreno; "No, what your talking about is the Chuck Wagon Competition. This is not the Chuck Wagon Competition. What these are... it's going to be a non motorized parade. It's going to be buggies and wagons"

Councilmember Bachman; "That's where I got confused then. That's why I brought it up."

Mayor Escapule; "We are striking the last sentence in this which is a further request for a special use permit for the parade. That's to be taken out because it's already been approved by a previous meeting."
