DISCUSSION: Board Member Andersen; "Is that the one, the refunding policy?"

Fire Chief Bruster: "Yeah! What's happen in the past is Arizona Law says that there has to be some kind of written statement from whom ever is requesting the money. In the past the City gets to have their money also refunded that they put in on behalf of the person but we've never had anything official in writing that said that they needed to make a statement to go into the files. So it's just kind of happened! To correct that missing letter if you will.

Fire Chief Bruster closes discussion and moves for the vote.

G. DISCUSSION AND/OR DECISION: Approval of a policy regarding Pension Fund investment.

MOTION by Mayor Escapule, **SECOND** by Board Member Roger King to approve a policy regarding Pension Fund investment.

DISCUSSION: Board Member Andersen; "That is the last page on the packet we have correct?"

Fire Chief Bruster; "Yes, it's the last page in the packet! Going through the records of the Fire Fighter Fund there been, essentially lost almost \$14,000 in the last three years. Just in refunds! That's not taking into account the \$4,800 that is paid out every year and were not currently right not at this rate with our volunteers we are not putting in that same amount of money that is leaving!"

Board Member Andersen; "So where is the money now if it is not in an interest bearing account?

Fire Chief Bruster; "It is being held in the City General Fund, earmarked for the ..."

Mayor Escapule: "It's a line item in the accounting process!"

Board Member Andersen; "So are we going to pull that out, put it into an interest bearing account?"

Fire Chief Bruster; "Well I know that we can't pull all of it out because they have to have access to be able to make the payments.

Board Member Andersen; "So we have about \$85,000 in there more or less."

Mayor Escapule; "How much is in there?"

Fire Chief Bruster; "\$86,000, I think."

Board Member Andersen; "So if take out"

Fire Chief Bruster; "What I would suggest if it would be acceptable is we get somewhere between six or seven hundred dollars a year by putting it into a shared certificate at Vantage West but it would require forty thousand dollars being used for the certificates."

Board Member Andersen; "So forty thousand dollars for a certificate. How many years is it?"

Fire Chief Bruster; "Anywhere from three to five!"

Board Member Andersen: "When I used to have money for a non-profit that I used to run what we would do is we would try to split it up into three different bank accounts, it's called laddering it, so that one would be due one year next one would be due a second year and the third would be due the third year so that, what happens if you do need that money you don't need to wait five years and you get a penalty. You could get after one year and after the second year. Once the first year comes due, you put it in a fourth year so that you have some money available."

Mayor Escapule: "I'll tell you what I would like to do! I would like to table this because this is kind of catching me off. I would like to table this until you and I could meet with Ruben."

Fire Chief Bruster; "Okay!"

Mayor Escapule: "Even though its Fire Relief and Pension Fund its still City Fund and I want to make sure that we are not doing something that is going to get us in trouble! I like your idea but I don't know if we can do it because of state statutes."

Fire Chief Bruster; "I tried to find out information on this from the others. We are the only municipality still actually has money on hand. Like Benson and them they have turned over all their funds to a retirement agency, retirement institutions."

Mayor Escapule; "I don't think we want to do that because that (inaudible), but I agree that we should be making some kind of interest on that kind of money! If it was a thousand dollars I would say it's (inaudible) but eight five thousand dollars is a significant amount of money to be just sitting in a checking account not bringing us any interest! In this motion I would like for you to help me and Ruben is to outline to me and Ruben all of the options that we just talked about so that when I talk to him we have something we can talk about rather than (inaudible) deer in the headlights."

Fire Chief Bruster closes discussion.
