### **PUBLIC HEARING**

City Attorney Roberts: This is going to be the first of our public hearings on the Home Rule Option that is the Alternative Expenditure Limitation issue that we go through every four years. The voters have been voting on it in Tombstone since 1985. It is passed every four years. What it does is it allows you as the council to set your expenditure ceiling or limitation based on how you determine you want to spend your revenues, and you can spend all of the revenues that come in. For instance, and I'm just going to use round figures, if we were limited to the state debt ceiling in the fiscal year 2025-26, which is when this will go, it will be 25-26, 26-27, 27-28 through 29. Right now, we have a proposed budget, let's just say 12 million, if the home rule or the state imposed ceiling limit was in place, we would only be able to expend somewhere around 8 million, which means you're going to have to cut somewhere, which means it's probably going to be capital projects, fire, or safety, because those are the areas that we have to spend a lot of money on. You have a lot of good services for seniors and stuff that most cities don't provide. If this proposition doesn't pass on the general election in November, then a lot of those services will have to be eliminated for at least the fiscal year 25-26 and 26-27. You can only present to the voters every two years and we couldn't even consider it again until 2026. You can spend up to what your limit was until it was actually passed. And then once it was passed, if it was passed in that year, then you could change to your new limitations. It's kind of important that the council is

SCM 06/04/2024 Page 1 of 5 able to set their limits on what they want for expenditures based on the revenues coming in.

Mayor Escapule: Thank you. Anybody have any questions?

Margie Lane asks off microphone if the Home Rule Option will be on November's ballot.

City Attorney Roberts: Yes, it will be on the November ballot, and there will be a big publicity pamphlet, too, that explains everything and gives proposed budgets and expenditures for the next four years. It can't be more than 30 days, so it'll be around the first part of October. It'll get sent to each household with a voter in Tombstone.

### **BUDGET WORK SESSION**

City Clerk Presti: Mayor and council, first, I wanted to say thanks my deputy clerk, Shelly, for working so hard on this budget. As you know, the last special meeting, we were pretty much thrown the budget at us, and we are fixing it into a new format, which Shelly has done, where it's easier to read.

Councilmember Regan: Thank you.

City Clerk Presti: We have also made the corrections that we had talked about at the last session. If you look on the first page of your summary of the proposed budget draft of the general, you'll see some red numbers there, those are the numbers that we took out of those departments that weren't being expensed. The cemetery fund, we took out \$13,600 because originally there was 19,000 that was not being expensed, and we moved it to other areas in the budget. We are fully balanced, and I will turn it over to Shelly to let you know some of the changes that she has made on the draft.

Deputy Clerk Kazda: We have a balanced budget, like Carissa said, there is still a lot of work to do, especially throughout the year, to keep our departments accountable and try and keep the expenditures going down. We went off of what we had from data and what we had for the initial budget and cleaned it up. I do not have the grants in your drafts done yet. Those don't affect the dollar amounts that the city has to put in. Those are non-matching. I will have those ready by the tentative budget next week. There are a few things once we get the insurance people in this week. We have insurance tied to every person, and we don't need to have that. That's some expenditures that we can remove and I may bring that dollar amount down before our next meeting. I just worked hard to get it to where it's at, and we're balanced. Any questions?

Mayor Escapule: Anybody have any questions?

But we'll have a balanced budget to go to council that night for a tentative adoption, which sets the limit, and we cannot change the limit higher, but we can still make changes and go lower before the final approval in July.

Councilmember Faulk: And there's not any rush to discuss that tonight. We can discuss that next week. Does that make sense? Or. We have plenty of time next week.

Deputy Clerk Kazda: To answer your questions?

Councilmember Faulk: Yes.
