#### ٧. COMMENTS BY MAYOR AND CITY COUNCIL

Councilmember Colin Regan: "Thank you very much to the citizens of Tombstone. I would like to thank my wife and daughter who really make it part of what I want to do every day to help this city. We had a great last couple of years with more things working for the future at Tombstone. Look forward to working with these new council members that we have. We got some great minds here, so I want to, you know, help build on some of their ideas. They got great ideas and I'd like to continue helping with what we're doing currently. I'm excited for the next couple of years as this is going to go on to help better our community. Also, I'd like to give a huge thank you to Charissa, the city clerk, as well as all the ladies at City Hall and Public Works for their hard work that often goes unnoticed. Thank you, ladies, and thank vou. Tombstone."

Councilmember John Goodspeed: "First of all, I do want to thank all the citizens of Ward 2 that elected me to this position. I am so honored to serve. Catherine and I have been living off and on in Tombstone since 2005 and made it our full-time home in 2020. I think this is about the best place to live in America. I mean, that's why we settled here. We've been in many parts of the country, and Tombstone cannot be beat. I'm looking forward to working with all the department heads. I have a large background in infrastructure and what have you, which maybe a little dry and dull, but I am very experienced in public safety, waterworks and other things like that. So, I'm looking forward to contributing as much time as I can toward the benefit of our city. And I want to thank my wife. Catherine. We just got

married here in town. After being together for 25 years, we decided it was time to make it official, so we have. Without any further ado, Mr. Mayor, I'll turn it back to you."

Councilmember Jimmy Green: "I just want to thank everyone in Ward 2, (Green misspoke, he is ward 3), for electing me to this position. I do not take this lightly. For me and my wife, Kathy, Tombstone is not only our home, it's our life. So, for the next couple years, I hope that we can be a positive influence to help generate more events for the town and to keep the communications open. I think that's a big part of it. And just do our best to represent Tombstone in a positive reflection. Thank you."

Councilmember Lillian Hritz: "I, too, want to thank all of my constituents who voted for me and placed their trust in me, helping to bring some transparency, as Councilman Green had also expressed. And I want to give you my promise here and now that I will listen and I will hear what you have to say, and I will be your voice here. So, I don't want to be up here and make any votes without knowing what you all would like for me, for how you all would like for me to vote. So, please keep that communication open and answer the phone when I call. It would be great to be able to hear you and understand what you're wanting from me up here. The two things that I campaigned on all along was redistricting. So, I'm hoping that I can work here to make that happen. I know it's not something that's going to happen overnight. I've already spoken with Charissa. So, our first step is to figure out how we fit the cost into the budget. So, just so you all know, Sheriff Dannels did make the comment of this is not easy work. I don't know how long I've already spent with Charissa trying just to learn today's agendas and what's on here. So, I want you to know that I'm doing my work to make that happen. And I will do the best I can to represent you while up here. Again, thank you all and thank the city for all the things they do as well."

Mayor Dustin Escapule: "Thank you. Well, as a lot of you do know, I've been around for a while. I'm going into my ninth term as the mayor of the city of Tombstone. I was first elected in 2000 and then again in 2004, then again in 2008 and then again in 2014. And I've been the mayor since 2014. I've seen a lot of ups and downs. I helped Tombstone go through a real hard time in 2008 when we had a real financial crisis. And then we also had a pandemic that we went through and we were able to survive it. Tombstone actually came out of it pretty well and did better than a lot of the other communities in Southern Arizona. I will tell you that this is a team effort. And the council, as they work with me over the next few months, they'll realize that not one person is above anybody else. We're all equal. We're all representing you folks, the citizens of Tombstone for the betterment of Tombstone. And I know that everybody says, well, you know, you're not paying attention to this, you're not paying attention to that. Let me tell you, we've got limited amount of resources. We have five people in public works right now. We have. The marshal's office is fully staffed at this time. The fire department, for the first time in the history of Tombstone is a full-time fire department. We've moved a long ways and there's a lot further to go, but we have to be cautious on how we take the steps and what direction we're going to take the steps in. I could talk on all night, but I'm not going to. I just want to thank all of the staff, all of the department heads for the hard work that they put into making this city a successful city for the last 10 years. And I'm sure we can do it for the next two years. So having said that, we move on to new business."

### DISCUSSION:

Councilmember Hritz: "There is. I would like to just confer with Charissa. Were you able to get the answers?"

City Clerk Presti: "Yes. So, there were some questions and we met with Deputy Clerk and Marshal and we called the Cochise County and there is. We need to amend the amount. It actually is \$21,173 total with a 2.5% increase, which is \$7,300 more than it was in 2017, but they did do new contracts based off of inflation and whatnot. Marshal, did you want anything to add to the MDCs that you're receiving?"

Marshal Adams: "So, the Spillman system that we operate under, that belongs to the county, is something that's absolutely necessary for our department to operate, is how we receive and dispatch calls for service and how we respond to them. We are purchasing, we've already purchased four brand new MDCs off of a grant. We have grant funding for seven more MDCs, which was the first one I mentioned in my police commissioner's report, all grant funded. But what that allows us to do is once we own our own computers, we don't have to pay the county for computers anymore. So that number, as we start to filter in the new computers and get rid of the old ones, will go down."

Councilmember Hritz: "Is that what MPC is?"

Marshal Adams: "MDC."

Councilmember Hritz: "MDC, that means computer?"

Marshal Adams: "Mobile data computer."

Councilmember Hritz: "I did have one more question. When I spoke with Charissa earlier, was about the Fire Department using that service as well. So are they able to use that? When you say communication to answer calls, is the Fire Department able to use that service as well?"

Marshal Adams: "So, the Fire Department doesn't currently have a contract with the county's IT for that service. However, in our last budget conversation, the Fire Department did ask for some MDCs, but because we're going to have several that we own that we're going to be able to maintain after the new ones are purchased, we're going to be able to transfer those to the Fire Department. They will work out their own agreement with the county for that service."
